# DEATH BENEFITS AVAILABLE TO THE SURVIVING FAMILIES OF LAW ENFORCEMENT OFFICERS KILLED IN THE LINE OF DUTY

## STATE DEATH BENEFITS

Those employees eligible for death or permanent disability are law enforcement officers, firefighters, prison guards, publicly employed emergency medical technicians, emergency management rescue specialists, and members of the Georgia National Guard when called into active state service by the Governor for law enforcement purposes. After determining that the injured person or the estate of the deceased is entitled to the financial benefit, the Indemnification Commission will issue an order authorizing payment. All claim applications must be submitted within 24 months from the date on which the permanent disability or death occurred. For part-time employees, claim applications must be submitted with 12 months.

#### GEORGIA STATE INDEMNIFICATION PROGRAM

The State of Georgia recognized the unique hazards inherent in certain public occupations that led to the General Assembly to establish the Georgia State Indemnification Program. The Program provides a financial benefit for designated public officers & public school personnel who are disabled or killed in the line of duty. Benefits under the Public Officers Indemnification Fund include payments for permanent disability, supplemental income, and for death. Eligible public officers include law enforcement officers, firefighters, prison guards, publicly employed emergency medical technicians, emergency management rescue specialists, state highway employees, and active members of the Georgia National Guard, when called in to service by the Government.

In the case of a death, payment shall be made to the surviving unmarried spouse or the dependants of the spouse or deceased person as shown in his or her most recent tax return or to the legal guardian. The current benefit is \$100,000 if elected in equal installments of \$1,666.66 per month over a five year period, or in a one-time payment this is reduced to its present value of \$73,390.39. Payment will be made to a designated beneficiary or estate of the deceased. Probate papers must be filed with the Indemnification Program Specialist before any payments are issued. Indemnification payments shall not be considered taxable income under state law.

**SPECIAL NOTE:** Public Safety officers **must designate a beneficiary** and changes should be made in writing to the Indemnification Commission when warranted.

### **EDUCATIONAL BENEFITS**

The Georgia Public Safety Memorial Grant provides grant funds to the dependent children of Georgia Public Safety Officers who were permanently disabled or killed in the line of duty. Funds may be used towards the cost of attendance at eligible colleges, universities, or technical colleges in Georgia. The scholarship is awarded on a first-come, first-served basis, as appropriated funds are available, and if eligibility requirements are met. ATLANTA BAR ASSOCIATION POLICE SCHOLARSHIP FUND provides college scholarships to the children of Atlanta Police Department officers who have been killed or disabled in the line of duty. Scholarships will be awarded by the Atlanta Bar Foundation on a year-by-year basis. A maximum of four scholarships may be awarded to any one applicant if eligibility requirements are met; however, an award to an applicant in any one year does not guarantee further awards in subsequent years. ## **WORKERS' COMPENSATION**

Workers' Compensation coverage is compulsory for employers with 3 or more employees in Georgia; however, waivers are allowed. The Georgia Workers' Compensation Act provides an accident insurance program for medical, rehabilitation, and income benefits for employees injured or killed on the job. Dependents of public safety officers killed in the line of duty may receive two-thirds of the officers' average weekly wage or a maximum amount provided for by the General Assembly. The employer of the worker is required to file a completed *Employer's First Report of Injury* (WC-1). ### **HEALTH BENEFITS**

Health benefits vary depending upon police department benefits. Spouses of state and county officers may elect to continue to participate in the same benefit program in effect at the time of the officer's death. Contact the Benefits Coordinator at your agency.

## **RETIREMENT/PENSION**

Individual cities and municipalities are responsible for providing retirement and pension plans for law enforcement officers. Contact your local agency's Benefits Assistance Officer.

## **GEORGIA SURVIVING SPOUSE TAX EXEMPTIONS**

Unmarried surviving spouses' of a peace officer or firefighter who was killed in the line of duty shall be entitled to a total exemption of the homestead from all ad valorem taxes. This Act was effective on January 1, 2007, and applies to all tax years beginning on or after that date.

Definitions: Ad valorem taxes means all state ad valorem taxes and all county, county school district, municipal, and independent school district taxes for county, county school district, municipal, or independent school district purposes including, but not limited to, taxes to retire bonded indebtedness. Homestead means each resident of the state who is the un-remarried surviving spouse of a peace officer or firefighter who was killed in the line of duty is granted an exemption on that persons homestead from all ad valorem taxes for the full value of that homestead.

#### PEACE OFFICERS ANNUITY AND BENEFIT FUND OF GEORGIA

Georgia peace officers, including correctional officers, probation officers, and others, that are members of the Peace Officers Annuity and Benefit Fund and who are killed or disabled in the line of duty may be eligible for certain benefits. The Peace Officers Annuity and Benefit Fund of Georgia was created by the General Assembly in 1950 to provide certain annuities and benefits to peace officers in the state of Georgia. Members of the fund killed in the line of duty may be eligible for \$5,500 death payment to their beneficiary (\$3,500 paid immediately upon the death, an additional \$2,000 is paid in 20

monthly installments of \$100 each). Persons disabled may be eligible for a monthly disability pension of \$235.
