### Optional Municipal Programs

- **Municipal Property Tax Deferral for Senior Citizens.** This program allows municipalities to enact a property tax deferral program to help elderly homeowners keep their homes. The program, which must be enacted by municipal ordinance, has age and income thresholds. See [36 M.R.S. chapter 908-A](#).
- **Municipal Property Tax Assistance.** This program allows municipalities to enact an ordinance to provide benefits to resident homeowners. See [36 M.R.S. chapter 907-A](#).
