# Statewide Maximum Qualification Income Amounts For <br> Property Valuation Limitation 2014 


#### Abstract

With the passage of State Question 714 on November 2, 2004, the United States Department of Housing and Urban Development (HUD) will determine the maximum qualifying income for the Property Valuation Limitation as provided in Oklahoma Constitution Article 10, §8C. The Oklahoma Tax Commission will provide the maximum qualifying income to the counties each year. [ref: Okla. Const. Article 10, §C amended]

# Statewide Maximum Qualification Income Amounts For Manufactured Home Personal Property Exemption 2014 

With the passage of Senate Bill 1449 in 2012, the qualifying income for the personal property exemption provided for in 68 O.S. § 2949 has changed. Qualification beginning January 1, 2014 is a maximum gross household income of $\$ 22,000.00$ or $50 \%$ of the Department of Housing and Urban Development (HUD) median income for the preceding year for the county or metropolitan statistical area where the property is located. The Oklahoma Tax Commission will provide the maximum qualifying income each year. [ref: 68 O.S. 2012 supp. § 2949(A)(2)]
